

# CALL FOR RESEARCH POSITION

REASSURE/BIM/01/18

The CISTER Research Unit hosted at the School of Engineering of Porto (ISEP), is opening 1 BIM research position, with ref. REASSURE/BIM/01/18. The work is to be developed under REASSURE, ref. NORTE-01-0145-FEDER-028550, supported by National Funds through the FCT/MCTES Portuguese Foundation for Science and Technology and co-financed by North Portugal Regional Operational Programme (NORTE2020), through the PT2020 Partnership Agreement and ERDF (European Regional Development Fund), in the following conditions:

1. SCIENTIFIC AREA

**Computer Science** 

2. REQUIREMENTS

The candidate must have a Master's Degree in Computer Engineering or Computer Science, experience in the development and formal verification of software, experience in security protocols and secure software development, experience in the development of embedded software in the industry. The candidate must also be fluent in written and spoken English.

The candidate should preferably have experience in software development using functional programming languages and experience in the usage of the Coq proof assistant.

## 3. CONTRACT DURATION

The position is of 6 months, possibly renewable, up to the limits stated in the regulation.

## 4. WORK PLAN

The Work Plan will involve:

- Develop scientific work in the area of domain specific languages to support the specification of nonfunctional properties of real-time embedded systems
- Develop scientific work in the area of formal verification and runtime verification of software for realtime embedded systems
- Prepare papers and technical reports related with research projects

## 8. SELECTION CRITERIA AND JURY

The Jury responsible for the selection will be composed by PhD members of the Research Unit, as follows: Chair: David Pereira (Project Coordinator - PI);

Effective Jurors: Dr. Eduardo Tovar (Substitute Chair) and Dr. Filipe Pacheco; Substitute Juror: Dr. Luis Lino Ferreira.

Assessment criteria will be:

- quality of CV and adequateness for the targeted research area (70%);
- interview (30%)

## **Remarks:**

Candidates may be excluded from the call for the following reasons:

- a) For not holding the academic degree and the requirements required in the call (bullet 2.);
- b) For getting a score lower than 9.5 in any of the assessment criteria stages;
- c) For not attending the interview or unavailability to provide any additional information required by the Jury during the selection process.

#### 9. NOTIFICATION OF RESULTS

The evaluation results will be disseminated electronically (by email).

#### 10. APPLICATION PROCEDURE
